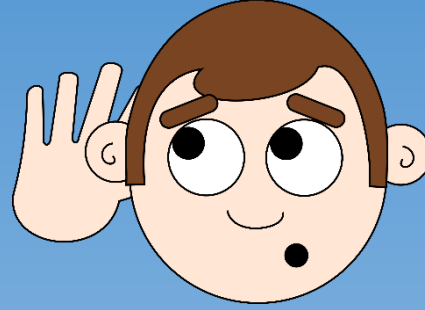


# *What is the Government Advisory Committee (GAC)?*
