- History of state direct deposit
 - Payroll
 - Commercial




Our current statistics for direct deposit

- Payroll
 - 91% (FY 11 cumm)
 - 95% (last month)
- Retirement
 - 88%
- Income Tax Refunds
 - 63.5%
- Commercial
 - 26.9% (FY 11 cumm)
 - ->40% (last month)

Annual statistics for income tax refunds

- FY 12 63.5%
- FY 11 61.6%
- FY 10 60.1 %
- FY 09 56.7%

EFT costs / efficiency

- \$.02-.03 per transaction
- Bulk rate posting is near \$.40/transaction
- Warrant distribution
- Mail returns
- Voids
- Staff attrition



EFT concerns for vendors

- SAMS implementation 7/1/97
- Detail information in a limited field
- Multiple paying agencies
 - Old mainframe systems
 - Subsystems with detailed vendor information
- Security around confidential information
- All or nothing options
- Multiple accounts



Legislation – Direct Deposit

- Legislation for direct deposit PA 97-0348
 - Employee Payroll or expense reimbursements must be paid by direct deposit or may be charged a \$2.50 processing fee
 - State payments to vendors that exceed allowable limit may be charged a \$2.50 processing fee
- IOC implementation
 - Focus groups
 - Mailings
 - Agency contacts



Payroll Bulletin 1-12

- Employees must be direct deposit or \$2.50 fee
- File layout changes
- Effective 2/1/12



Accounting Bulletin 173

- State Employee reimbursements using certain DOCS
- Vendor payments > the allowable limit (minimum 30)
- Hardships
- Exemptions



Accounting Bulletin 175

- IOC liaison program
- Hardship petition
- Implementation date 7/1/12



Accounting Bulletin 176 and 177

- (176) Multiple bank account options
- (177) Hardship inquiry screen and file



Expanded Vendor Remittance (EVR)

- Web site changes where a vendor can view their confidential data using a PIN number
- Adding additional data that can be downloaded
- E-mail notification of payments



Accounting Bulletin 172

- No interest payment <\$5
- DHS and HFS exceptions



Legislation- State Offset

- PA 97-0759
 - Threshold set at \$250
 - 60 day protest
 - \$15 fee
- IOC implementation



Accounting Bulletin 181 and 185

- Sets new threshold of \$250 (University exception)
- Electronic submission of debt
- 60-day protest
- \$15 fee
- Effective date 9/5/12
- No manual transactions after 8/31/12

Accounting Bulletin 186

- Vouchers <\$5 cannot be paid except by direct deposit
- Multiple warrant systems
- Exceptions- legislative branch;



Legislation – Minority Business

- Public Act 97-0590
 - Background
 - IOC implementation



Accounting Bulletin 174

- Contract award codes subject to a \$15 fee
- Effective 8/26/11
- First payment



Legislation – IOC cleanup

- Public Act 97-0932
- Background
 - Travel Vouchers
 - Contract limit raised to \$20,000
 - 30 day late filing contracts
 - Interest payments after 6/30



Accounting Bulletin 183 and 184

- \$20,000 contract threshold
- 30 day late filing contracts
- Electronic filing of contracts
- Travel vouchers receipts and signatures



Future Bulletin

- Address interest payment made after June 30th
- 60 days after issue
- New DOC



Legislation – Lapse Extension

- Public Act 97-0732 (BIMP bill)
 - Background
 - IOC implementation



Accounting Bulletin 180

• Extend lapse to 12/31



Legislation – Financial Reporting Standards Board

- Creates Financial Reporting Standards Board
- Set guidelines for improving financial reporting



Scanning Contracts

- Background
- IOC implementation
- Unique contract number
- Accounting Bulletin 178
 - Beginning in FY 13 contract numbers cannot be reused
- Future agency submission



Website changes

- Expanded Vendor Remittance (EVR)
 - Vendors can see detail confidential information
- LEDGER
 - Transparency and accountability
- POWER
 - Small and minority owned business have the resources needed to compete for state contracts



Future changes

- On-line reports
- Additional on-line transactions (IW, receipts)
- SharePoint options
