CALL TO ORDER

A Chief Internal Auditor Roundtable meeting hosted by the State Internal Audit Advisory Board (SIAAB) was held online through Zoom on Monday, May 24, 2021. The meeting was called to order at 8:30 A.M. by SIAAB Conference Coordinator Jay Wagner

Introductions
